Fort MAC LRA Board Updates

 2. The GDOT offer to acquire land to use for easement for traffic signal improvements along Lee Street.
- David stated the interior of the FORSCOM building has been cleaned out. Also, Easterly is very open to hiring local and would seek subcontractors with the RFP process.
- Pete Hayley reviewed the Small Business/Vendor Directory that the LRA is compiling. Additions to the LRA Vendor List with small businesses in the area should be submitted to Pete Hayley or Jocelyn Bivins.
- Joyce Sheperd stated that she was excited about the partnership with Easterly and additional discussions will be included in the Jobs Creation Taskforce meetings.
- Ricardo Jacobs, vice chair, asked about future events or movie nights on the LRA property. David advised that they are open to suggestions especially since spring and Braves games are coming soon. Email suggestions to David Burt.
