RESOLUTION OF THE MEMBERS OF THE MCPHERSON IMPLEMENTING LOCAL REDEVELOPMENT AUTHORITY

CONCERNING APPROVAL OF THE NEW INSURANCE PACKAGE FOR FISCAL YEAR 2017 AND OTHER OFFICIAL ACTIONS

A meeting of the Members (the "Members of the Authority") of the McPherson Implementing Local Redevelopment Authority (the "Authority") was held on the 16th day of June, 2016, at which meeting a quorum was present and voting throughout. WHEREAS, after discussion concerning the updated insurance coverages and costs, and the related insurance carriers for fiscal year 2017 (the "FY 2017 Insurance Package"), and upon the recommendation of the senior staff of the Authority, the Members of the Authority have determined that it is in the best interest of the Authority to approve the FY 2017 Insurance Package, as described in **Exhibit A** attached hereto, and all actions taken by or on behalf of the Authority which are consistent with approval of said FY 2017 Insurance Package.

NOW, THEREFORE, BE IT RESOLVED, that the Members of the Authority hereby ratify, confirm and approve in all respects, (a) the FY 2017 Insurance Package and (b) the negotiation, execution and delivery, as the case may be, of the contracts, agreements, certificates and other official actions which are deemed necessary or appropriate by the Chair, Vice Chair or Executive Director of the Authority in connection with the placement of the coverages with the applicable insurance carrier(s) as set forth in the FY 2017 Insurance Package summary attached as Exhibit A to this Resolution.

FURTHER RESOLVED, that all acts and doings of the officers, employees, attorneys or agents of the Authority whether done before, on or after the date of adoption of this Resolution, including the actions taken by such parties relating to the procurement of the FY 2017 Insurance Package, and which are in furtherance of the performance of the matters contemplated herein shall be, and the same hereby are, in all respects approved, ratified and confirmed.

FURTHER RESOLVED, that if any one or more of the provisions herein contained shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such covenants, agreements or provisions shall be null and void and shall be deemed separate from the remaining agreements and provisions and shall in no way effect the validity of any of the other agreements and provisions hereof.

FURTHER RESOLVED, that this Resolution shall take effect immediately upon its adoption by the Members of the Authority and any provisions of any previous resolutions in conflict with the provisions herein are hereby superseded or repealed (as and to the extent of any such conflict).

FURTHER RESOLVED, that the Secretary of the Authority is hereby directed to file a copy of this Resolution with the minutes of the proceedings of the Authority.
