Announcements and Welcome:

Vice-Chairman Marvin Arrington, Jr., called the meeting to order at approximately 1:00 P.M. and thanked everyone for their presence, stating that Chairman Butts would be joining shortly.

Approval of Agenda:

A motion to approve the agenda was properly made and seconded. Approval was unanimous.

Public Comment:

The Vice-Chairman invited public comment, and no one took advantage of submitting comments via our public comment email address during the allotted time.

Item 4: Executive Session:

The Vice-Chairman asked for a motion to reconvene in Executive Session and to reconvene to open session to approve and vote on matters before the Board at that time. A motion to approve was properly made and seconded. Approval was unanimous.

The Chairman read the following statement:

"Ladies and Gentlemen: In accordance with O.C.G.A. Section 50-14-4(B), a quorum of the McPherson Implementing LRA is present and has agreed to enter executive session by a majority vote. The purpose for the closed section is for members to (1) deliberate regarding the acquisition of interest in real estate, (2) other legal matters, (3) personnel

matters. The specific reasons for the closed session will be entered in the official minutes and a notarized affidavit will be executed stating that the executive session was devoted to matters within the exceptions provided by law."

After the Vice-Chairman read the statement, a motion to approve was properly made and seconded. Approval was unanimous.

The Board went into Executive Session for approximately one hour.

The Vice-Chairman stated the purpose of the Executive Session was to discuss legal matters, real estate matters, and personnel matters.

Motion to return to Open Session:

The Vice-Chairman asked for a motion to return to open session. A motion was properly made and seconded. Approval was unanimous.

Mr. David Burt, Interim Executive Director, stated that two resolutions were discussed during the Executive Session. The first resolution would allow the McPherson Implementing Local Redevelopment Authority to lease property from Tyler Perry Studios for a period of six to twelve months. A motion to approve was properly made and seconded. Approval was unanimous.

A second resolution was discussed that would allow the McPherson Implementing Local Redevelopment Authority to license the leased property back to Tyler Perry Studios for the placement of temporary housing. A motion to approve was properly made and seconded. Approval was unanimous.

It was emphasized that these lease transactions would not impact the property owned by the McPherson Implementing Local Redevelopment Authority.

Adjournment:

A motion to adjourn was properly made and seconded. Approval was unanimous. The meeting adjourned at approximately 2:09p.m.

- (1) I was the presiding officer of McPherson Implementing Local Redevelopment Authority (the "Authority") "Special Called Meeting held on the 5th day of May 2020.
