## RESOLUTION OF THE MEMBERS OF THE MCPHERSON IMPLEMENTING LOCAL REDEVELOPMENT AUTHORITY

## CONCERNING THE CREATION OF A PUBLIC ART ADVISORY COUNCIL

A meeting of the Members (the "Members of the Authority") of the McPherson Implementing Local Redevelopment Authority ("the Authority") was held on the 19th day of October 2017, at which meeting a quorum was present and voting throughout. Upon motion duly made and seconded, the following resolutions were adopted by the Members of the Authority at such meeting: For all purposes hereof, this resolution, as a whole, shall be referred to as the "Resolution."

**WHEREAS**, the Authority is responsible for the redevelopment of 145 acres of land at the former Fort McPherson Army Post, and

**WHEREAS**, the Authority wishes to improve its property by placing public art displays throughout the redevelopment of its 145 acres, and

**WHEREAS**, the Authority recognizes that public art provides opportunities for citizens of Atlanta, East Point, and Fulton County to enjoy quality art and helps make this area a better place to live, and

WHEREAS, the Authority seeks to implement a selection process for all public art projects, and

**NOW, THEREFORE, BE IT RESOLVED**, that the Members of the Authority shall create a Public Art Advisory Council (PAAC) for the purpose of determining the appropriateness, timing, and placement of visual and other art forms and shall have the power to approve all members of the PAAC,

**FURTHER RESOLVED**, that upon selection of an artist and or project, the project and/or artist will be presented to the Authority for approval,

**FURTHER RESOLVED**, that the Authority shall empower the Executive Director or his designee to solicit and procure public art projects and, upon approval of the Authority, enter into service agreements for public art projects as recommended by the PAAC,

**FURTHER RESOLVED,** that the actions provided for in the foregoing Resolution be commenced as soon as possible,

**FURTHER RESOLVED,** that the Secretary of the Authority is hereby directed to file a copy of this Resolution with the Minutes of the proceedings of the Authority.

**FURTHER RESOLVED,** that upon adoption of this resolution the the PAAC will be formed with the initial members as follows:
