## RESOLUTION OF THE MEMBERS OF THE MCPHERSON IMPLEMENTING LOCAL REDEVELOPMENT AUTHORITY

CONCERNING THE NEGOTIATION, EXECUTION AND DELIVERY OF AN AMENDED SERVICES AGREEMENT WITH THE ATLANTA DEVELOPMENT AUTHORITY D/B/A INVEST ATLANTA TO PROVIDE INTERIM EXECUTIVE DIRECTOR TO MILRA ON A TEMPORARY BASIS; AND OTHER OFFICIAL ACTIONS.

A meeting of the members of the Board of Directors (the "Board of Directors") of the McPherson Implementing Local Redevelopment Authority ("MILRA") was held on 30<sup>th</sup> day of September 2019, at which meeting a quorum was present and voting throughout. Upon motion duly made and seconded, the following resolution was adopted by the Members of the Board of Directors of MILRA at such meeting: For all purposes hereof, this resolution, as a whole, shall be referred to as the "Resolution."

WHEREAS, after acceptance of the resignation of the Executive Director, the Board held a discussion concerning interim leadership of MILRA while conducting the national search for a new Executive Director. The Board determined that it is in the best interest of MILRA to authorize the negotiation, execution and delivery of an amended Services Agreement with the Atlanta Development Authority d/b/a "Invest Atlanta," to obtain Interim Executive Director Services for MILRA from Invest Atlanta on temporary basis while a national search for a new Executive Director is conducted, at a cost not to exceed \$10,000 per month.

NOW, THEREFORE, BE IT RESOLVED, that the members of the Board of Directors of MILRA hereby ratify, confirm and approve in all respects the negotiation, execution and delivery of an amended Services Agreement with the Atlanta Development Authority d/b/a "Invest Atlanta," and any other official actions which are deemed necessary or appropriate by the Chair or Vice Chair of MILRA in connection with the provision of Interim Executive Director Services for MILRA from Invest Atlanta on temporary basis while a national search for a new Executive Director is conducted, at a cost not to exceed \$10,000 per month.

FURTHER RESOLVED, that all acts and doings of the officers, employees, attorneys, or agents of MILRA whether done before, on, or after the date of adoption of this Resolution, including the actions taken by such parties relating to the Services Agreement with Invest Atlanta shall be, and the same hereby are, in all respects approved, ratified and confirmed.

**FURTHER RESOLVED**, that if any one or more of the provisions herein contained shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such covenants, agreements or provisions shall be null and void and shall be deemed separate from the remaining agreements and provisions and shall in no way effect the validity of any of the other agreements and provisions hereof.

**FURTHER RESOLVED**, that the Secretary of MILRA is hereby directed to file a copy of this Resolution with the minutes of the proceedings of MILRA.

This Resolution shall take effect immediately upon its adoption by the Board of Directors of MILRA and any provisions of any previous Resolutions in conflict with the provisions herein are hereby superseded or repealed, as and to the extent of any such conflict.
