

**RESOLUTION
OF THE MEMBERS OF THE
MCPHERSON IMPLEMENTING LOCAL REDEVELOPMENT AUTHORITY**

ACCEPTING THE INDEPENDENT AUDIT FINDINGS FOR FISCAL YEAR 2020

A meeting of the members (the "Members") of the McPherson Implementing Local Redevelopment Authority (the "Authority") was held on the 18th day of February, 2021. A quorum was present and voting throughout the aforementioned meeting. Upon motion duly made and seconded, the following resolutions were adopted by the Members of the Authority at such meeting: For all purposes hereof, this resolution, as a whole, shall be referred to as the "Resolution."

WHEREAS, the Authority previously selected Banks, Finley, White, & Co., Certified Public Accountants ("MILRA's Auditor") as its independent auditor for the performance of financial audits as well as the preparation of the related audited financial statements of the Authority; and

WHEREAS, pursuant to the Bylaws of the Authority the annual financial audit must be completed within One Hundred Eighty (180) days after the closing of the preceding fiscal year; and

WHEREAS, Banks, Finley, White & Co. have completed the audited financials and submitted the 2020 Fiscal Year Audit to the staff; and

WHEREAS, the Members of the Authority on recommendation of the staff and after reviewing the Audit have determined that it is advisable and in the best interests of the Authority accept the Audit for the 2020 fiscal year.

NOW, THEREFORE, BE IT RESOLVED, that the Members of the Authority hereby ratify, confirm and approve in all respects the finding of the 2020 Audit.

FURTHER RESOLVED, that all other acts and doings of the officers, employees or agents of the Authority whether done before, on or after the date of adoption of this Resolution which are in conformity with the purposes and intent of this Resolution, and in the furtherance of the execution, delivery, filing and performance of the matters contemplated herein shall be, and the same hereby are, in all respects approved, ratified and confirmed.

FURTHER RESOLVED, that the actions provided for in the foregoing resolutions be commenced as soon as practicable.

FURTHER RESOLVED, that this Resolution shall take effect immediately upon its adoption by the Members, any provisions of any previous resolutions in conflict with the provisions herein are hereby superseded or repealed (as and to the extent of any such conflict), and any previous resolutions adopted by the Members which are in conflict with the actions taken in this Resolution are hereby waived.




