

**A RESOLUTION
OF THE MEMBERS OF THE MCPHERSON IMPLEMENTING LOCAL
REDEVELOPMENT AUTHORITY**

**APPROVING THE EXECUTION AND DELIVERY OF AN AMENDMENT TO LEASE
AGREEMENT (THE "AMENDMENT") TO THAT CERTAIN LEASE AGREEMENT
(THE "ORIGINAL LEASE") WITH TPS AT FORT MAC, LLC (THE "TENANT")
RELATING TO THE LEASE OF A PARKING LOT; AND TAKING OF CERTAIN
OTHER RELATED ACTIONS**

A meeting of the members (the "Board of Directors") of the McPherson Implementing Local Redevelopment Authority (the "Authority" or "Fort Mac LRA") was held on the 21st day of April, 2022. A quorum was present and voting throughout the aforementioned meeting. Upon motion duly made and seconded, the following resolutions were adopted by the Board of Directors at such meeting: For all purposes hereof, this resolution, as a whole, shall be referred to as the "Resolution."

WHEREAS, the Authority operates a portion of the former Fort McPherson military installation and is charged with redeveloping same which rests inside the territorial limits of the City of Atlanta; and

WHEREAS, the Authority has the sole responsibility for the redevelopment of the former base; and

WHEREAS, the Authority and Tenant are parties to the Original Lease for the purpose of Tenant's leasing certain property from the Authority for use as a parking lot (as more particularly described therein, the "Property"); and

WHEREAS, the Authority and the Tenant desire (i) to extend the term of the Original Lease until December 31, 2022 and (ii) to amend the Original Lease to (a) provide T.D. Jakes Real Estate Ventures, LLC, a Texas limited liability company, a right to terminate the Original Lease (as amended) upon thirty (30) days' prior written notice delivered after June 30, 2022 and (b) provide Tenant a right to terminate the Original Lease (as amended) upon thirty (30) days' prior written notice; and

WHEREAS, the Board of Directors has determined that it is in the best interest of the Authority to amend the Original Lease as provided above.

NOW, THEREFORE, BE IT RESOLVED, that the Chair, Vice Chair or the Executive Director be and they hereby are, authorized and empowered, for and on behalf of the Authority, as the case may be, to execute and deliver the Amendment with the Tenant in substantially the form of Exhibit A attached hereto, and to do any and all acts and things that any one or more of the officers of the Authority deems, in the exercise of his or her discretion, necessary, desirable, or appropriate in connection with or to advance the purposes and intent of this Resolution, including without limitation, the execution and delivery of any documents or agreements relating to the matters contemplated in or implementing the purposes and intent of this Resolution (which shall

be conclusive evidence of the appropriateness thereof and the approvals contemplated by this Resolution). The Secretary (or his or her designee) is further authorized to attest any of the foregoing signatures and to affix the seal of the Authority to any documents, instruments or agreements, as and to the extent necessary or convenient.

FURTHER RESOLVED, that if any one or more of the provisions herein contained shall be held contrary to any express provision of law or contrary to the policy of express law, though not expressly prohibited, or against public policy, or shall for any reason whatsoever be held invalid, then such covenants, agreements or provisions shall be null and void and shall be deemed separate from the remaining agreements and provisions and shall in no way effect the validity of any of the other agreements and provisions hereof.

FURTHER RESOLVED, that the actions provided for in the foregoing resolutions, as and to the extent not taken, be commenced as soon as practicable.

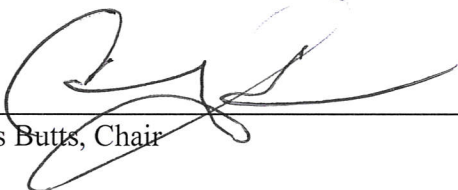
FURTHER RESOLVED, that the Secretary of the Authority is hereby directed to file a copy of this Resolution with the minutes of the proceedings of the Authority.
