Update on Oral History/Public Art Project:

The Chair announced Althea Brown would give an update, however, in the absence of David Burt this item was deleted from the agenda earlier in the meeting. The Chairman asked for a vote from the Sub-committee to have this item reinstated. A motion was properly made to approve and accept the addition and seconded. Approval was unanimous.

Ms. Althea Brown, Project Creator for the Oral History/Public Art Project funded by Elevate, gave a brief overview of the project. She stated that project participants shared their personal history and experiences while at Fort McPherson through interviews with Ms. Brown who had their pictures turned into large color posters and displayed on the outer walls of the property with QR codes which allow viewers to hear their stories via video. The posters are displayed on the wall along the fence at the main Lee Street entrance to Fort Mac as well as on the gate at the Campbellton Road entrance. An opening ceremony replete with an oral history of Fort Mac presented by Ms. Brown was held on Saturday, September 24, 2022. The exhibit will run through October 9, 2022. The public is invited to tour the project and enjoy the colorful history of Fort McPherson.
