WHEREAS, the Auditor has completed its financial audit of the Authority and presented its report to the staff of the Authority (such report, the "2024 Audit"); and

WHEREAS, the staff of the Authority has reviewed the 2024 Audit and recommended that the Members of the Authority approve the 2024 Audit; and

WHEREAS, the Members of the Authority on recommendation of the staff and after reviewing the 2024 Audit have determined that it is advisable and in the best interests of the Authority to accept the 2024 Audit.

NOW, THEREFORE, BE IT RESOLVED, that the Members of the Authority hereby ratify, confirm, and approve in all respects the finding of the 2024 Audit.

FURTHER RESOLVED, that all other acts and doings of the officers, employees or agents of the Authority whether done before, on or after the date of adoption of this Resolution which are in conformity with the purposes and intent of this Resolution, and in the furtherance of the execution, delivery, filing and performance of the matters contemplated herein shall be, and the same hereby are, in all respects approved, ratified, and confirmed.

FURTHER RESOLVED, that the actions provided for in the foregoing resolutions, as and to the extent not taken, be commenced as soon as practicable.

FURTHER RESOLVED, that this Resolution shall take effect immediately upon its adoption by the Members, any provisions of any previous resolutions in conflict with the provisions herein are hereby superseded or repealed (as and to the extent of any such conflict), and any previous resolutions adopted by the Members which are in conflict with the actions taken in this Resolution are hereby waived.

FURTHER RESOLVED, that the Secretary of the Authority is hereby directed to file a copy of this Resolution with the minutes of the proceedings of the Authority.
